**Position to be filled:** Supervisor

**Required Qualifications/Essential Duties:**

- Associate's degree in any are plus three years' experience in any Gaming, Investigation or Tribal Regulatory Field;
- Valid California Driver license – **Required**
- Must be insurable through companies' carrier and maintain throughout employment- **Required**
- Must be able to obtain a California Gaming License within 90 day introductory period and maintain throughout employment- **Required**
- Valid Fingerprint Rolling Certificate or must be able to obtain within 90 day introductory period- **Required**
- Performs background investigation for licensing of all key employees. This will include financial and credit checks, criminal checks, civil checks, employment verification, education verification, military record checks, and personnel reference checks.
- Prepares written reports regarding suitability, license denials, revocations, suspensions, and specific license requirements or conditions and submit report to the Gaming Commission, Law Enforcement Agencies. NIGC and CA Division of Gaming Control.
- Maintain knowledge of current laws pertaining to regulatory issues surrounding Indian Gaming, Fair Credit Act, and Americans with Disabilities act.
- Have the ability to network with other Tribal Government and Law Enforcement checks.
- Have the ability to prepare written investigative reports, detailing steps taken and result of background investigation.
- Testify and/or present evidence at hearings regarding licensing sanctions imposed by the Gaming Commission.
- Finger printing applicant who are applying for licensing. General knowledge of the Live scan equipment, and the ability to correct minor problems as they occur.
- Maintains record files on all applicants as well as statistical records of all commission license activity.
- Determines what vendors require licensing under Tribal Ordinance and Compact requirements. Issues and receives vender and principle license applications and fees, conducts suitability background investigations on eligible business and their principals. Makes vendor-licensing recommendations to the Commissioners.
- Performs search of court records to determine suitability of applicants.
- Drive company or personal vehicles to conduct business on behalf of the Backgrounds Department.
