## **Required Qualifications/Essential Duties:**

- High School Diploma or General Education Degree (GED) plus two years of experience working a substance abuse setting
- Valid California Driver License
- Must be insurable through company's carrier and maintain throughout employment
- Must possess one or more of the following certifications SUDCC, CAODC, CADC, CAC, CATC, RAS, and/or RADT
- Have knowledge of local, state, and federal standards and requirements that pertain to/or impacts Tribal communities.
- Maintain knowledge and practice of Substance Abuse Treatment modalities per local, state, and federal practices.
- Adhere to and maintain knowledge and practice Mandated Reporting practices.
- Educate youth on the health risks of the use of alcohol and drug products.
- Provide community-wide resources information for youth who need assistance in addressing a problem with alcohol or drugs.
- Promote and facilitate groups in the areas related to chemical dependency, violence prevention, gang awareness, and positive social skills.
- Support youth in developing Critical Thinking and Problem-Solving Skills.
- Raise community awareness in an innovative and positive manner.
- Complete screenings, intakes, orientations, assessments, treatment planning, counseling, client education, referrals, and case management services.
- Consistently communicate with clients, family, and support system. Good communication is vital.
- Meet with individuals and family members in the office, school, and home as necessary.
- Prepare (SMART) goals worksheet identifying mutually agreed-upon short- and long-term goals and objectives so clients can achieve a sober and healthy lifestyle.
- Continually assess/reassess the client's needs and appropriate level of care.
- Assist with in-patient treatment program placement and provide follow-up support services.
- Assist with crisis interventions as needed.
- Available for on-call rotation. Must be willing to work on weekends and during after-school hours as needed when youth are not at school.
- Provide case management services.
- Provide resources and coordinate services with other providers as needed.
- Conduct home visits as needed.
- Remain culturally humble and respectful in all client and staff interactions.
- Maintain client/Tribal Member records according to HIPPA and 42 CFR and adhere to all confidentiality and standards.
- Attend court hearings as needed.
- Perform other duties as assigned.
